1. Introduction

At Ark Property Centre, protecting your privacy is fundamental. This Privacy & Cookie Policy explains what personal data we collect, why we collect it, how we use it, and how we keep it secure. We comply with the UK General Data Protection Regulation (UK GDPR), the Data Protection Act 2018, and other relevant legislation.

2. What Personal Data We Collect

We may collect and process the following categories of personal data:

- Identity Data: Name, title, date of birth, marital status, gender
- Contact Data: Address, email, phone number
- Financial Data: Proof of funds, bank statements, mortgage details, salary
- Transaction Data: Details of property purchases/sales, solicitor and surveyor information
- Technical Data: IP address, browser type, time zone, device info
- Marketing & Communications Data: Preferences regarding marketing communications
- Other Data: Correspondence, feedback, and interactions with us

3. How We Collect Your Data

We collect personal data when you:

- Fill in forms on our website or in person
- Contact us by phone, email, or social media
- Engage with our services (e.g., buying, selling, letting, or renting property)
- Use our website and digital tools

4. Legal Basis for Processing

We process your personal data under the following lawful bases:

• Contractual Obligation – To fulfil our contract with you

- Legal Obligation To meet legal requirements (e.g., anti-money laundering)
- **Legitimate Interest** For operational, marketing, and fraud prevention purposes
- Consent For optional marketing communications (you can withdraw anytime)
- **Public Interest** Where required for compliance with public interest duties

5. How We Use Your Data

We use your data to:

- Provide and manage our services
- Verify your identity and meet anti-money laundering regulations
- Communicate with you regarding your property transaction
- Send you marketing communications (if opted in)
- Improve our website and services through analytics
- Fulfil legal and regulatory obligations

6. Sharing Your Data

We do **not sell** your data. We may share your information with:

- Solicitors, surveyors, and financial advisors involved in your transaction
- Contractors and other estate agents for service fulfilment
- IT and website providers (e.g., Driveby Websites, Ark ICT)
- Law enforcement, regulatory authorities, and credit reference agencies where legally required
- Newsletter provider (Brief Your Market) for e-newsletter distribution

All third parties we share data with are required to comply with GDPR and ensure appropriate security.

7. Data Retention

We retain your data:

- For at least five years to meet anti-money laundering and financial regulations
- For up to seven years after your last interaction, unless legal requirements dictate otherwise
- For as long as necessary to fulfil the purpose for which it was collected

8. Your Rights

You have the right to:

- Access your personal data
- Request correction of inaccurate or incomplete data
- Request erasure or restriction of your data in certain circumstances
- Object to processing, particularly for direct marketing
- Withdraw consent where applicable
- Request data portability to another service provider

- We use secure systems and procedures to protect against unauthorised access

We may also conduct electronic identity and credit checks as part of our due diligence process. Failure to provide satisfactory proof of identity or source of funds may result in delays or an inability to proceed with your transaction.

We cooperate fully with the National Crime Agency and other law enforcement authorities by reporting any suspicious activities or transactions.
